4. Standby funds for Sooke Multi-Belief Initiative for All-Candidates Forum October 15, 2020. Moki suggested that we make available \$100 to cover any expenses for this event. It was felt that, since we now have a new policy on financing projects, this request should be denied and proper procedures be followed. Moki agreed and will inform the organizing group accordingly. He will forward them a copy of the policy.
5. Report on Sooke Council meetings (Hester) Susan B did a stellar presentation about the OCP being developed through lens of the climate emergency. The response from Council was underwhelming although the matter was sent to staff and the OCP steering committee for their considerations. The Council meetings for September 14 (Alan D) and 28 (Jo) were monitored with notes being made available soon.
6. OCP and Climate Action Team – (Susan C) The goal is to create a 10-year plan for how Sooke will grow. Currently the push for growth and “business as usual” is in full sway. This orientation is at odds with our intention to reduce the speed and intensity of growth as a dominant value along with a ramping up of the engagement to deal with what the Climate Emergency requires of us for the sake of our children and grandchildren. The September 30 meeting of the OCP steering committee emphasized the importance of public engagement and sent out a survey for people to respond to. We need to get copies of this survey immediately. Another document was mentioned: “What municipalities can do to address climate disruption.” Again we need to familiarize ourselves with this and other relevant resources.

7. West Coast Environmental Law / The Climate Doctor – (Oliver and Jo) After some information about WCEL and about Dr. Silvie Harder (The Climate Doctor) was shared, the group was keen to explore how we can take advantage of this unique opportunity. Jo will send off a letter to Dr. Harder right away.
